



**AGREEMENT, OF FEBRUARY 25, 2019, OF THE RESPONSIBLE GAMBLING ADVISORY COUNCIL,
BY WHICH THE SECTIONS THAT COMPLETE IT ARE APPROVED**

The Advisory Board for Responsible Gaming (CAJR) was created at the beginning of 2013, without legal structure and without formalization as an organ, with the basic objective of advising the Directorate General for the Regulation of Gambling (DGOJ) in the definition and design of the Responsible Gaming Strategy and in establishing the guidelines to be followed by the gaming sector in this area.

The experience acquired since then recommended the redefinition of this figure and this was implemented from different milestones: the signature of the Order communicated by the Minister of Finance of 2018 October 25th, which formalizes and regulates the CAJR, published in the institutional web portal of the DGOJ on 2018 November 26th, the publication of the appointment of the members of the Advisory Board on the same date; and the adoption of an agreement approving the CARJ organization and operation internal regulations.

The new CAJR as a novelty compared to its previous version, may work in Plenary or in Sections, each of which will be a distribution of the projects to be treated by reason of the subject they are dealing with. These Sections will be integrated by the members of the Board who voluntarily, in light of their training or experience in the gaming environment, consider their contribution maximized in the projects included in these Sections.

AGREEMENT:

ANNEXED

SECTIONS THAT MAKE UP THE RESPONSIBLE GAMING ADVISORY COUNCIL

By virtue of the provisions of Article 7.3 of the Communicated Order of the Minister of Finance of 2018 October 25th, which formalizes and regulates the Responsible Gaming Advisory Board, the following Sections are established:

- A. Scientific Section. - Through projects that deepen knowledge of addiction to gambling and its bio-psycho-social implications from an academic-scientific perspective.
- B. Participant Protection Section. - In which fundamentally will be treated initiatives whose main objective is the development of policies of responsible game of protection to the participant.
- C. Game and Society Section. - In which will be inserted, among other issues, those projects through which establish ways of collaboration with other actors involved with the game as well as establishing communication strategies that will facilitate the identification of games of chance as a activity of special characteristics to take into account when practiced or commercialized.
- D. Assistance Section. - With main focus of action in the knowledge of the social reality of those who have been diagnosed with a mental disorder of gambling addiction, as well as the specific needs of this group
